REGULATION TO AMEND THE TARIFF FOR INSURED HEARING AIDS AND RELATED SERVICES

Health Insurance Act
(chapter A-29, s. 3, 7th par. and s. 72.1, 1st par.)

1. SCHEDULE I of the Tariff for insured hearing aids and related services (chapter A-29, r. 8) is amended:

(1) by replacing, in every occurrence in PART I, the words “NATIONAL HEARING SERVICES INC. ” with the words “UNITRON HEARING LTD. (UNITRON ® CANADA)”;

(2) by replacing DIVISION IV of PART I with the following:

“DIVISION IV: HEARING AID COMPONENTS AND ACCESSORIES

(3) by replacing DIVISION I of PART III with the following:
