

## What you need to know about the visual aids loaned to you

The Régie de l'assurance maladie du Québec has created this Guide to inform you of your obligations regarding the use of visual aids and accessories loaned to you for your various daily activities.

### General information

You are responsible for the visual aids and accessories issued to you today. They are loaned to you by your rehabilitation centre and may not be sold, rented out, given away or modified.

If these devices or accessories are lost, stolen or broken, you will have to pay the replacement costs. We therefore suggest that you check whether your insurance covers these risks.

If you cease to use the visual aids or accessories loaned to you or if you leave Québec, you must return them to your rehabilitation centre.

### Computer aids

It is important to know that you are not allowed to copy or update adaptive or commercial software on loan to you from your rehabilitation centre.

Please obtain authorization from the centre before installing any new software. This prevents the loaned computer from malfunctioning or needing to be repaired, which would deprive you of the aid you need. Even on your own computer, you should also check with your centre before installing any new software. You need to make sure that it is compatible with the software you have on loan.

Moreover, it is essential that you install antivirus software on the computer you are using, if it does not already have one, and update it regularly, according to the supplier's recommendations. You must also be careful when downloading software or files from the Internet. The same is true when saving files on storage devices, that can transfer data from one computer to another, such as USB memory keys.

In the event that modifications or repairs are made, your rehabilitation centre reserves the right to verify any and all software or hardware in your computer.

The contract you sign confirms that the rehabilitation centre has advised you of your obligations and responsibilities, and that the aids and accessories loaned to meet your needs remain the property of the rehabilitation centre.
